**ORDER**

**AND WHEREAS**, the application was processed and the inspection of the institution was conducted and finally SRC granted recognition for offering B.Ed course with an intake of 100 students on 29.08.2007.

**AND WHEREAS**, now, a shifting permission has been received from the Institution on 26.03.2014 stating as follows:

*"We, the management of Satyam Educational Society would like to request you to grant permission for shifting Satyam College of Education from current premises i.e., Satyam College of Education, K.E Complex, Bellary road, Near RTC Bus Stand, Kodumur, Kurnool District, Andhra Pradesh to the highly furnished own building meeting all NCTE norms situated at Survey No. 348 & 555, Pyalukurthy Post & Village, Kodumur Mandal, Kurnool District.*

*NCTE has granted permission for Satyam College of Education in 2007, situated in a lease building lease agreement is for 30 years). NCTE has also given permission for our Satyam D.Ed College in 2012, situated at Survey No. 348 & 555, Pyalukurthy Post, Kodumur Mandal, Kurnool (District. Which is our own building (Ground floor and part of 1<sup>st</sup> floor) equipped with all best possible amenities.*

*As two colleges are located in different places, it has become difficult for the management to monitor both. Thus we have constructed further part of D Ed. College building (remaining 1<sup>st</sup> floor & complete 2<sup>nd</sup> floor). Newly constructed building is just 3 kms. Away from the old lease building. Also new building is more spacious has better transport facility, equipped with better amenities like drinking water, washrooms, more lush green, silent, peaceful climate altogether with a good congenial atmosphere for better learning.*

*We here with enclose all necessary documents of Satyam College of Education & Satyam D.Ed College like building plan, Sanitary certificate, building completion certificate of new building & processing fee DD for Rs. 50000 and other documents for your kind perusal".*

**AND WHEREAS**, the Southern Regional committee in its 268<sup>th</sup> meeting held during 4<sup>th</sup> & 5<sup>th</sup> June, 2014 considered the written reply and other documents submitted by the institution and decided to cause inspection at the new premises Under NCTE Act. to examine whether the Institution fulfils all the requirements as per the norms, for the existing programme, subject to the condition that the deficiencies, if any, are duly rectified by the Institution, as per the norms.

AND WHEREAS, the Southern Regional Committee in its 282<sup>nd</sup> meeting held during 26<sup>th</sup> February, 2015 Considered the Show Cause Notice Reply and Decided as under:-

- Staff list shows inadequacies 2 Positions (Physical Education & Fine Arts) are vacant even in the first batch of 8 faculty.
- Issue Show Cause Notice accordingly.

AND WHEREAS, as per the decision of SRC, a Show Cause Notice is prepared.

AND WHEREAS, in the meantime, On 02.03.2015 before issuance of Notice to the institution, on seeing website, a reply to the Show Cause Notice received by this office from The Principal, Satyam College of Education Bellary Road, Near R.T.C Bus stand, Kodumur -518 464, Kurnool District, Andhra Pradesh.

AND WHEREAS, the Committee Regional Committee in its 289<sup>th</sup> meeting held on 23<sup>rd</sup> June 2015, considered the matter, show cause notice reply from the institution vide their letter dated 02.03.2015, and other related documents of the institution, decided as under:

1. Affidavit received
2. Permit shifting
3. B.Ed & D.Ed together- they now assume 'composite character,
4. As per Revised Provisional Recognition Order, ensure adherence to new norms by 31.10.2015
